In June 2001, a tragic stabbing occurred at Ikeda Elementary (affiliated with Osaka Kyoiku University), resulting in eight children dead and fifteen injured. The media made much of the suspect's history in psychiatric hospitals and his diagnosis, and many at mental health facilities were concerned about the influence it would have on their patients. The following data is excerpted from the results of a survey conducted by the National Federation of Families of the Mentally Ill in Japan in an attempt to clarify what effect the media coverage had on the mentally disabled who were receiving outpatient care and on their families.

## 月例経済報告

### 景気「回復」の兆し 経済財政担当相も笑顔

竹内内閣府経済財政総合担当相は、20日午の月例経済報告に関する記者会見で、景気回復の兆しを指摘した。2000年10月の国内総生産(GDP)は前年同月比で1.2%増加し、前四半期累計で4.0%増えた。これは、1999年4月の成長率に匹敵する水準に回復したと見られる。竹内氏は、この成長率を「2000年を通じて平均して1.5%程度の成長を確保し、景気回復の兆しを確かなる」と述べた。
